## **Privacy Policy**

### Introduction

At Origins Web3 LLC ("Company" or "We"), we are committed to protecting the privacy of our users. #### Information Collection

We collect a variety of information from our users, including:

- Information that you provide by responding to gueries related to the Website.

### Information Use

- To enforce or apply our terms of use, Website rules and other agreements.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Company, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

### Third-Party Access to Data

We may share the information we collect with third-party service providers, such as analytics tools, who assist us in providing our services and running our business. These third parties are not required to sign a confidentiality agreement and are only permitted to use the information we share with them for the purpose of providing the services we have contracted them for or to improve our services.

We may also share anonymized data with third-parties for analytical and research purposes, however this data will not include personal information that can be used to identify you.

We will take reasonable steps to ensure that the recipients of your information are using the information only for the purposes for which we disclose it to them and comply with the applicable laws and regulations.
